

**BOROUGH OF RIVERDALE**

**ORDINANCE NO. 20 - 2006**

**AN ORDINANCE AMENDING CHAPTER 113 OF THE REVISED GENERAL ORDINANCES OF THE BOROUGH OF RIVERDALE AND DELEGATING THE AUTHORITY TO APPROVE THE GRANTING OF RAFFLE AND BINGO LICENSES TO THE BOROUGH CLERK**

**WHEREAS**, the Legalized Games of Chance Control Commission has promulgated rule amendments which permit the Municipal Governing Body to delegate, by Ordinance, the authority to approve the granting of raffle and bingo licenses to the Municipal Clerk; and

**WHEREAS**, the Mayor and Council of the Borough of Riverdale desires to delegate the authority to approve the granting of raffle and bingo licenses to the Borough Clerk.

**NOW, THEREFORE, BE IT ORDAINED** by the Mayor and Council of the Borough of Riverdale, in the County of Morris and State of New Jersey, as follows:

**Section 1.** Chapter 113 of the Revised General Ordinances of the Borough of Riverdale entitled "Licenses and Permits," shall be amended by the inclusion of new Article II which shall be entitled "Issuance of Raffle or Bingo License by Borough Clerk," and which shall read in its entirety as follows:

**ARTICLE II**

**Issuance of Raffle or Bingo License by Borough Clerk**

**§ 113-3. Authority to approve the granting of raffle and bingo licenses.**

The Borough Clerk is hereby delegated the authority to approve the granting of raffle and bingo licenses within the Borough of Riverdale.

**Section 2.** If any section or provision of this Ordinance shall be held invalid in any Court of competent jurisdiction, the same shall not affect the other sections or provisions of this Ordinance, except so far as the section or provision so declared invalid shall be inseparable from the remainder or any portion thereof.

**Section 3.** All Ordinances or parts of Ordinances which are inconsistent herewith are hereby repealed to the extent of such inconsistency.

**Section 4.** This Ordinance shall take effect immediately after final passage and publication in the manner provided by law.
