ORDINANCE NO. 6-2008

ORDINANCE AMENDING CHAPTER 45 OF THE REVISED GENERAL ORDINANCES OF THE BOROUGH OF RIVERDALE AND PROVIDING FOR EMPLOYEE REIMBURSEMENT FOR CERTAIN EXPENSES

BE IT ORDAINED by the Mayor and Council of the Borough of Riverdale, in the County of Morris and State of New Jersey, as follows:

Section 1. Chapter 45 of the Revised General Ordinances of the Borough of Riverdale, Section 45-19 entitled "Reimbursement for certain expenses" shall be amended to read in its entirety as follows:

§ 45-19. Reimbursement for certain expenses.

- A. An employee will be reimbursed for all expenses incurred for travel, lodging, meals, courses, seminars, etc., as authorized by the Mayor and Council. All receipts and bills must be forwarded to the Borough Clerk on an appropriate voucher for reimbursement at the end of each month but in no event later than 60 days after incurring such expense.
- B. Any employee who is requested by the Borough to use his personal car in the performance of his work during regular working hours shall receive reimbursement in the maximum amount permitted under Internal Revenue Service Regulations in effect at the time of travel.

Section 2. If any section or provision of this Ordinance shall be held invalid in any Court of competent jurisdiction, the same shall not affect the other sections or provisions of this Ordinance, except so far as the section or provision so declared invalid shall be inseparable from the remainder or any portion thereof.

Section 3. All Ordinances or parts of Ordinances which are inconsistent herewith are hereby repealed to the extent of such inconsistency.

Section 4. This Ordinance shall take effect immediately after final passage and publication in the manner provided by law.
